America's Most Wanted 2009 All-Star Award

There are eight dedicated first responder finalists for the 2009 All-Star Award. One of the finalists is from Arizona.

William (Bill) Weigt began in law enforcement in 1996 as a correctional officer with the Arizona Department of Corrections. During the following eight years, his assignments included main intake coordinator, squad leader of the tactical support unit, firearms instructor, armorer, testing coordinator and gang intelligence officer. In July, 2004, he graduated from the police academy and began working for the Peoria Police Department. In his second month of service, he received a Life Saving Award for helping to rescue an elderly man from drowning after driving his vehicle into a pond. In the following two years, he also received four unit citations and a commendation.

In late 2005, Detective Weigt was shot while conducting a high-risk stop, following a drug related shooting; he awoke three days later to find that he was paralyzed from the chest down. He received a Distinguish Cross and a Police Star for his work as a first responder that day and continues to work for the Peoria Police Department as detective investigator in the robbery unit. Detective Weigt's will to make a difference in the face of tragedy, is a demonstration of strength and inspiration in his community. He has coordinated numerous fundraising events for local officers who have died in the line of duty and has been a motivational speaker at about 20 different organizations and schools. He has also been coaching youth football for the last eight years and took his team to the National Championships in 2007.

Phoenix Mayor's Commission on Disability Issues, Employment Education & Training Grant

The City of Phoenix and the Phoenix Mayor's Commission on Disability Issues is offering grant awards, from \$500 up to \$3,000 each, to eligible Phoenix residents with disabilities who require financial assistance in overcoming barriers in education, training, or employment related needs. There is a life time maximum of two grant awards per applicant, not to exceed \$6,000. Grant applicants must be at least a senior in high school and eighteen years of age. The program will reopen for new applications once per quarter until available funding is exhausted. Applications will be turned into the City of Phoenix, Equal Opportunity Department, and reviewed by a committee comprised of commissioners, City staff, and community representatives.

Citizens with disabilities must apply within the specified timeframes set for each award period. Applicants must submit an application and one page explanation of the grant need in detail. Proof of reasonable costs, including bids, invoices, etc., must be included in the application. Successful applicants will receive vouchers that they provide to vendors, who in turn will bill the grant fund. All funds will be provided directly to the vendor organization providing the good or services.

Thursday night, April 30th on CBS at 9 pm (8 pm CT) - check local listings. CSI: Crime Scene Investigation will feature a full storyline about coroner Dr. Robbins, portrayed by actor and disability rights advocate Robert David Hall. This is the first full storyline for Dr. Robbins since he started on the show nine years ago that shows more dimensions to his character. CBS has taken the lead in hiring of actors with disabilities in TV programming, going back to the 1980s.
