Perfect Timing for Arizona's Disability Vote Coalition

Just in time for Arizona's important 2010 election, the Just Vote Arizona Disability Coalition (JVADC) has been revitalized. The Coalition, comprised of 17 prominent organizations including Arizona Bridge to Independent Living, Arizona Center for Disability Law, Arizona Statewide Independent Living Council, Arizona Spinal Cord Injury Association, and Goodwill of Central Arizona, couldn't have reconvened at a better time. Now more than ever it is critical for the disability community to come together with a loud voice and a strong presence at the Arizona State Legislature. At stake are crucial services vital to the disability community that is in jeopardy of drastic budget cuts due to the state's dire financial situation.

Recently unveiled, JVADC's website (www.jvadc.org) gives visitors an opportunity to register to vote, find out who their legislators are and learn about pertinent information important to voters with disabilities. The website also provides visitors an opportunity to sign up for the Action Alert Network, so that they can be alerted to what's happening at the state legislature, receive the Ballot Buzz Newsletter and learn about voter registration events. The best past of the website can be found in the voter assistance section, where voters may request assistance filling out a voter registration form, filling out their absentee (mail-in) ballot and transportation to go to a polling place.

All of the assistance provided goes to support JVADC's purpose: to establish and sustain a statewide network of grassroots, disability related organizations and voter participation activities across Arizona. The Coalition's non-partisan activities include voter education, voter registration drives and get out the vote campaigns. Visit the JVADC website to sign up for the Action Alert Network; it's the best way to stay informed and give people with disabilities the necessary power to protect critical disability resources in Arizona.

Reduced Cab Fare

Coupons for Cabs (480) 962-7433

The Coupons for Cabs Program provides affordable cab service for senior citizens age 65 and over and persons with disabilities who live in Chandler, Gilbert, Mesa and Tempe.

Eligible persons can purchase coupons at a significant discount. The participants can use the coupons to help pay for cab trips they take on any of the authorized cab companies.

- An application must be completed and approved before cab coupons may be purchased. Call (480) 962-7433 to receive an application if you don't already have one.
- Once enrolled, a participant pays nominal co-pay for a coupon book valued at \$10. Coupons have an expiration date and must be used prior to the expiration date. The expiration date is three to six months from the date of coupon purchase.
- Chandler, Gilbert, Mesa and Tempe residents can purchase 10 books per month per person (\$100 value for \$25).
- Coupons may be used for the taxi fare and the tip as well.
- For wheelchair users, mini vans from Discount Cabs are wheelchair accessible. Participants who use wheelchairs should call Discount Cab and let them know a wheelchair accessible van is needed to ensure the same rate is charged as non-accessible taxi vehicles. Otherwise, a boarding charge of approximately \$2.50 will be charged. Specialty cabs charge a boarding charge of \$25.00 or more.
- When you begin using the Cab Coupon Program, make sure when you call to arrange your ride you: O Inform the cab company you are using the coupons. Ask for an estimate of the trip cost.

Once enrolled in the Cab Coupon Program, you will receive welcome packet that includes the list of authorized taxi companies.

Transit Fare Discounts

There are many options with the bus and light rail. In addition to the extensive choices in routes, discounted fares are also available. A 31-day Local Reduced Fare pass is available for \$27.50 or pay 85 cents for one-way travel. A Local Reduced All-day pass provides unlimited rides for \$1.75 when purchased off the bus. Purchased on the bus, a Local Reduced All-day pass is \$2.60.

- ✓ Information for other income
- ✓ Information for all deductions and credits
- √ If filing Married Filing Joint return, both spouses must be present to sign forms.
- ✓ Any information received from the Internal Revenue Service.

Advocacy Opportunity – Medicare Therapy Caps

The Medicare Therapy Cap went into effect on January 1, 2010.

Currently there are two therapy caps, one for physical therapy and speech language pathology and one for occupational therapy. The therapy caps are set at \$1860 per beneficiary per year. The therapy cap applies to all Medicare beneficiaries in all Part B health care settings, except hospital outpatient departments. Beneficiaries that exceed their therapy cap may have to choose between forgoing necessary care or paying 100% of the cost out-of-pocket over their Medicare coverage. Senior citizens who suffer from a stroke, or have Parkinson's disease, spinal cord injuries or osteoporosis are more likely to be the type of patient needing such care.

Background - The therapy cap returned on January 1, 2010 as a \$1,860 per beneficiary per year cap. This cap is a shared cap for physical therapy and speech language pathology services and exempts the hospital outpatient department.

Medicare Part D Changes

Changes in the Law Could Make More People Eligible for Extra Help in 2010 SSA Publication No. 05-10040, August 2009,

Beginning January 1, 2010, changes in the law will make it easier for some people to qualify for Extra Help with their Medicare prescription drug plan costs. Under the Medicare Improvements for Patients and Providers Act:

- We will no longer count as a resource any life insurance policy; and
- We will no longer count as income the help you receive regularly from someone else to pay your household expenses—food, mortgage, rent, heating fuel or gas, electricity, water, and property taxes.

Power Soccer - Get Involved

For those who are unfamiliar with the sport of power soccer, here is a brief explanation. This sport is played by people who use electric wheelchairs in their everyday lives. With the use of their chairs, the athletes compete in this exciting wheelchair sport. The basis of power soccer is similar to regular soccer: get the ball in the goal. But instead of using their feet, the athletes use their chairs and dribble the ball with the aid of foot guards. To help picture what the guards look like, think of having a giant football helmet facemask at the feet of the players.

There are four players on each team (3 on offense and 1 goalie), and games are played on a basketball court. Each game has two 20-minute halves and uses a running clock, similar to able-bodied soccer. Power Soccer is a great sport and we highly recommend experience it first hand!

Art That Heals Tohono Chul Park Exhibit Hall, Tucson, Arizona

Tohono Chul Park is seeking submissions by artists from Arizona and the greater Southwest for Art That Heals, an exhibition of artwork that has a healing purpose. Original artwork in all media is welcome for Art That Heals. Possibilities include: mandalas, icons, shrines or other images used for mediation, prayer or healing; subjects dealing with prayer or intercessions to saints; artwork made in response to grief or to help the maker deal with a spiritual or psychological problem; and artwork that engenders or represents hope and healing.

The exhibit's aim is to explore how art images can be powerful objects that positively influence our spirits. For instance, icons and mandalas can be meditative aids, and art activities frequently are used in therapeutic settings to provide patients with a means of self expression and healing. Artmaking can be cathartic, helping individuals restore balance and health in their lives after experiencing loss, illness or suffering. A notebook placed in the exhibit will allow visitors to record their own experiences with the healing power of art.

Artists who wish to create new work for the Art That Heals exhibit may submit sketches and a narrative proposal outlining their ideas. Completed works may be submitted in slide, photo, or digital media/CD format. Submissions should include size, media, and an accompanying statement about each artwork and its relevance to the theme. No fee required for submissions. Each artist may submit up to six pieces for consideration.
