The Teddy Pendergrass Alliance and the National Spinal Cord Injury Association Join Forces

The National Spinal Cord Injury Association (NSCIA) and the Teddy Pendergrass Alliance (TPA) have joined forces with other disability organizations in a shared effort to postpone implementation of a troublesome new Power Mobility Devices (PMD) Coverage Policy issued by the U.S. Department of Health and Human Services Centers for Medicare and Medicaid Services (CMS). Slated to take effect November 15th, 2006 the new policy would limit or deny medically appropriate power mobility to Medicare beneficiaries with mobility disabilities such as spinal cord injury, ALS, muscular dystrophy, cerebral palsy, and severe brain injury. The regulatory changes would have wide-ranging impact as State Medicaid agencies and other third party payers adopt this policy and reset their fees.

This is the first joint action taken by NSCIA and TPA since they announced a partnership earlier this week during the 2006 Spinal Cord Injury Hall of Fame Gala at the Kennedy Center in Washington, DC. NSCIA and TPA have pledged to work together, and with other disability leaders to confront the issues that continue to impact people with spinal cord injuries and diseases.

"I am outraged by the insensitivity, the lack of recognition of the hardships this presents, the limits on independence this would create and the overall cloud of unconcern it shows," said Teddy Pendergrass, founder of TPA.

Marcie Roth, Executive Director and CEO of NSCIA agrees, adding, "This is a critical time to act in collaboration with other organizations in our community, such as TPA, to make sure our community has the strongest voice possible on this urgent and important issue."

Should this new rule take effect, a chain reaction of problems is anticipated. The new coverage policy known as the Local Coverage Determination (LCD) does not address progressive loss of function as a consideration in determining the most appropriate solution for someone needing power mobility. The new fee schedule drastically reduces reimbursement for durable products used by consumers with significant disabilities by up to 40%. Therefore, these reductions will eliminate the availability of the appropriate power wheelchair and service required by most Medicare beneficiaries with complex mobility needs.

An outdated pricing methodology that has been universally recognized as flawed (including recognition by CMS) is the "root" of the CMS fee schedule problem. For example, the fee schedule provides that a Group 2 power wheelchair (less complex) will be reimbursed at a higher rate than a Group 3 power wheelchair (more complex).

In addition to the problems these reductions will and have already caused, CMS published the new policy and fee schedule with an implementation date that gives individuals needing power mobility products, clinicians, manufacturers and medical equipment providers less than 8 weeks to adjust

their practices and businesses. These changes are the most dramatic since the establishment of the power mobility benefit under Medicare with 64 new codes, new pricing, new coverage criteria, and new documentation requirements. There is simply not enough time to make the adjustments necessary to implement these new changes.

To prevent major access problems for Medicare beneficiaries, CMS MUST postpone the November 15th Power Mobility Device LCD Determination and Fee Schedule in order to resolve all of these pressing issues.

In addition to postponing the power mobility reductions, Roth, Pendergrass and others recommend that a new Fee Schedule is established using a rational methodology and accurate product classifications and pricing data and that the necessary changes to LCD are made to eliminate the risk of Medicare beneficiaries not receiving appropriate power mobility technology. Once all identified issues are resolved, final pricing, coverage policy, and documentation requirements should be published, and allow for a 120 day implementation period prior to the effective date.

The number of people who will ultimately be adversely affected by this is too large to ignore. The urgency of this matter is clear, as the November 15th implementation date approaches. Medicare's power mobility reductions must be postponed. Failing to meet the mobility needs of people with disabilities has a significant impact on the individual, states and taxpayers. Inadequate mobility devices will lead to dangerous and costly secondary complications, limit independence and employment options and deny equal access to programs and services which will trigger unnecessary and costly legal action.

The mission of the Teddy Pendergrass Alliance is to urge and assist individuals with spinal cord injuries to lead a productive life through education and employment.
